 - iii. Respond in trauma-informed ways; environment and language matters
 - iv. Reduce/Eliminate re-traumatizing people
 - b. Use names, never call people by their role (except the judge)
 - c. Erase negative terms from your interactions.
 - i. Substance use challenges/struggles v substance abuser
 - ii. Mental health challenges/struggles v unmanageable/ crazy/r-word
 - iii. Manipulative/attention-seeking to looking for validation or relationship-seeking
 - iv. Find the positive adaptive value; many people are simply relying on maladaptive coping mechanisms
 - d. Learn difference between misbehavior & chronic stress-induced/stress-related behavior
 - e. Learn and advocate for what is happening to regulate stress, for the individual, family, community; recognize and acknowledge what they are doing
