WHY WE FIGHT FOR REPRODUCTIVE LIBERTY

"All my life, I've fought for the right to seek a safe, affordable, and legal abortion. **The issue is deeply personal for me.**"

HEN I WAS eight years old, my parents divorced, leaving my mother with four young children to raise on her own. I remember the night she was rushed to the hospital after she was found bleeding on the floor of our bathroom. Years later, I learned that my mother had attempted to abort her pregnancy – and had succeeded.

Eventually, she fell in love again but was abandoned when she became pregnant. After she gave birth, the doctor performed a hysterectomy that went wrong, and my mother died five months later, at the age of forty, leaving behind four children. This was in 1962, ten years before abortion was made safe and legal in this country.

Nobody should have to endure the suffering that my mother did. The right to decide whether and when to become pregnant, use temporary or permanent birth control, or seek abortion care is fundamental, and access to reproductive health care impacts all of us. What's more, we know that when the government threatens or violates our reproductive liberty, low-income people and Black, Indigenous, and people of color (BIPOC) are disproportionately harmed.

Reproductive rights are under attack like never before in our lifetimes. That's why the ACLU's work to defend those rights is essential, and it's one of the reasons why I joined the ACLU of Vermont's Board of Directors. The ACLU works tirelessly in courts, statehouses, and

communities across the country, fighting for the freedom and dignity of all people – including the right to reproductive healthcare.

I'm proud to be with the ACLU in this fight, and I hope you will join me in supporting this vitally important work at this critical time.

OUR FIGHT FOR REPRODUCTIVE RIGHTS IN VERMONT

- Three years after its founding, the ACLU of Vermont joined a court challenge 1970 to overturn the Vermont law that prohibited abortions.
- We and our allies in the state house helped defeat parental notification 1982 legislation.
- We won a court ruling stating that Vermont's refusal to pay for medically necessary 1986 abortions as part of the Medicaid program violated the state Constitution.
- We helped pass H.57, which codified and preserved the right to an abortion 2019 in Vermont.
- After four years of advocacy and public testimony in which the ACLU and our 2022 allies again played a central role, the Vermont House of Representatives voted to pass Proposition 5, the Reproductive Liberty Amendment. The RLA will be on the ballot in November 2022 and, if it passes, will make Vermont the first state to enshrine reproductive liberty in its state constitution.

This work is far from over, and with attacks on reproductive rights intensifying nationally, our success in Vermont is more important than ever before. We are grateful to our supporters for keeping up the fight, in Vermont and nationwide.
